Sub: FIR in connection with theft of Electricity

Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that one Sri Murari Mandal, S/O Basudeb Mandal, Vill+PO- Sitalpur, PS-Nandakumar, Dist-Purba Medinipur has committed theft in respect of Electricity U/S 135 of Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 18.01.2017 at around 12:30 Hours I, Sri Suprakash Maiti, AE & Station Manager, Nandakumar CCC along with Sunit Kumar Maity, ACM, Nandakumar C.C.C. and Rabindranath Das, I.M, Nandakumar C.C.C. and other officials had been to the village- Sitalpur for inspection purpose and after observing all formalities we entered into the domestic premises of Sri Murari Mandal, S/O Basudeb Mandal, Vill+PO- Sitalpur, PS-Nandakumar, Dist-Purba Medinipur and resumed inspection. The said consumer Sri Haripada Dinda has got one meter bearing ID number : 201486051 and during inspection it was found that the said consumer Sri Murari Mandal was consuming electricity unauthorizedly in the adjacent fishery (commercial purpose) by tampering of incoming service cable before entry into energy meter in view of less recording of energy meter and resulting causing loss of revenue of WBSEDCL at the tune of load 1.0 KW as it was found during physical verification.

As theft of electricity was detected some portion of PVC cable two core black colour (approx. length is 30 mtr.) with tamper portion 2 Meter approximately was seized under memo of seizure list in presence of the witnesses. The said PVC cable duly packed and Labeled at the inspection site. After the inspection is over the inspection team left the aforesaid premises at 13:00 hours and removed the unauthorized PVC cable and disconnected the service line accordingly.

Thus the accused Sri Murari Mandal, S/O Basudeb Mandal, Vill+PO- Sitalpur, PS-Nandakumar, Dist-Purba Medinipur has committed an offence under section 135 (i)(b) of the Electricity Act 2003 read with the Amendment Act 2007 for commission of theft in respect of power.


