Sub: Prayer for lodging an F.I.R.

Sir,

I SI Narugopal Biswas of Nandakumar PS, Purba Medinipur do hereby lodge a written complaint to the effect that on 16.06.17 at 23.15 hrs ASI Bablu Dolai, Duty Officer of Nandakumar PS received an information over telephone that some villagers of Bar Bahichberia Village under Nandakumar PS was continuing a cultural programme using loud speaker in a high volume without any permission from concerned authority causing annoyance and disturbance of local persons. ASI Bablu Dolai, Duty Officer of Nandakumar PS noted the fact in G.D vide Nandakumar PS G.D.E No. 677 Dt. 16.06.17 and informed O/C Nandakumar PS. I SI Narugopal Biswas accompanied with ASI Tapas Patra, ASI Aminul Islam, C/1560 Nimai Mahapatra, C/1058 Swapan Kr. Das, NVF Sankar Hazra, L/C 1797 Sumana Ghora C166 Bechuram Pal, C/338 Tapan Maity rushed to the spot as per order of O/C Nandakumar PS to comply the information.

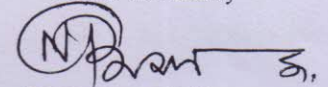
On 17.06.17 at about 00.15 hrs, we had been to village Bar Bahichberia and found some villagers of Bar Bahichberia Village under leadership of (1) Mrityunjay Barik S/O- Lt Subal (2) Madhab Barik S/O- Maniklal both of Bar Bahichberia (3) Nakul Barik S/O- Jhantu Barik of Vill- Dakshin Sautanchak all of PS- Nandakumar and (4) Mike operator Ramesh Barman S/O- Badal Chandra Barman of Vill- Dwariberia PS- Sutahata all of Dist- Purba Medinipur were continuing a cultural programme using loud speaker in a high volume. We requested them to stop the loud speaker as it was dead hours of night but they did not pay any heed to our words and also failed to produce any valid permission from concerned authority for using loud speaker in a high volume. Then I stopped the loud speaker and disbursed the spectators cum mob and seized following apparatus using for loud speaker preparing proper seizure list and label duly signed by the witnesses. At that moment the villagers shut down the electricity/ Generator and fled away.

Returning to PS, I am submitting this complaint against (1) Mrityunjay Barik S/O- Lt Subal (2) Madhab Barik S/O- Maniklal both of Bar Bahichberia (3) Nakul Barik S/O- Jhantu Barik of Vill- Dakshin Sautanchak all of PS- Nandakumar and (4) Mike operator Ramesh Barman S/O- Badal Chandra Barman of Vill- Dwariberia PS- Sutahata all of Dist- Purba Medinipur and other villagers of Bar Bahichberia for continuing a cultural programme using loud speaker in a high volume without any permission from concerned authority with a prayer to register a Case under proper section of Law
