Sir,

In producing herewith two arrested accused person namely Uttam Samanta (55 yrs), S/O Lt. Ajit Kr Samanta and Shibani Samanta (50 years) W/O Uttam Samanta both of Vill. Dhannyaghar, PS- Nandakumar, Dist. Purba Medinipur along with seized articles I, SI Dilip Kr. Das of Nandakumar PS do hereby submit a written complaint to the effect that on 21.06.17 at 07.05 hrs I along with C/338 Tapan Kr Maity, C/1038 Goutam Das, and LC 1797 Sumana Ghora all of Nandakumar PS left for PS area for performing mobile duty vide Nandakumar PS CC No - 1419, Dated - 21.06.17. At about 12:15 hrs received source information that above noted person were selling illegally Country Spirit at Dhannyaghar village at their home. On receiving the information I along with force rushed to the spot at about 12:55 hrs and found that the above noted accused person was apprehended by local people and manhandled. On enquiry it came to learn that above noted persons were selling Country Spirit to the local people. Seeing the Police they tried to flee away but somehow we managed to detain him. On being asked they stated that they were selling Country Spirit without any valid documents. Then no founding any other alternative way I arrested them on 21.06.17 at 13.15 hrs maintaining all formalities U/S 46 A (c) of Bengal Excise Act-1909. and I also seized at 13.25 hrs the following articles from their possession under proper seizure list duly signed by the accused and witnesses.

Description of the seized item : 1) 600 ml. each bottle, 11 bottles country spirit contained in a bags,

2) 08 (eight) ltrs ID liquors with a plastic jaricane.

I also took 02 (two) bottles country spirit and 1 (one) ltr. ID lioquor from the seized items as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So, I pray that a specific case may kindly be started against the arrested accused person namely Uttam Samanta (55 yrs), S/O Lt. Ajit Kr Samanta and Shibani Samanta (50 years) W/O Uttam Samanta both of Vill. Dhannyaghar, PS- Nandakumar, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909 for selling liquors illegally.
