Sir,

In producing herewith arrested accused person namely Sahadeb Jana (45 yrs), S/O Lt. Harekrishna Jana of Vill. Chak Durgabasan, PS- Nandakumar, Dist. Purba Medinipur along with seized articles I, SI Partha Pratim Maiti of Nandakumar PS do here by submit a written complaint to the effect that on 24.06.17 at 14.25 hrs I along with C/901 Susanta Panda C/ 1541 Amit Kr. Das all of Nandakumar PS left for PS area for performing mobile duty vide Nandakumar PS CC No - 1445, Dated - 24.06.17. At about 19:55 hrs received source information that above noted person was selling illegally Country Spirit and ID Liquors at Chak Durgabasan village at his home. On receiving the information I along with force rushed to the spot at about 20.25 hrs and found that the above noted accused person was selling Country spirit and ID liquor to the local people. Seeing the Police he tried to flee away but somehow we managed to detain him. On being asked he stated that he was selling Country Spirit and ID liquor without any valid documents. Then finding no other alternative way I arrested him on 24.06.17 at 20.45 hrs maintaining all formalities and I also seized the following articles from his possession after preparing proper seizure list duly signed by the accused and witnesses.

Description of the seized item: 1) 600 ml. each bottle, 11 bottles country spirit contained in a bags,

2) 08 (eight) ltrs ID liquors with a plastic jaricane.

I also took 01 (one) bottle country spirit and 1 (one) ltr. ID lioquor from the seized items as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So, I pray that a specific case may kindly be started against the arrested accused person namely Sahadeb Jana (45 yrs), S/O Lt. Harekrishna Jana of Vill. Chak Durgabasan, PS- Nandakumar, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909 for selling liquors illegally.
