Sir,

In producing herewith one arrested accused person namely Raju Santra (32) S/O- Lt. Ranajit of vill- Kamarda, PS- Nandakumar Dist- Purba Medinipur along with following seized articles under proper seizure list—i) 10 Ltrs. Jaricane contains 06 Ltrs I/D Liquor (Cholai) ii) 06 bottles Country spirit.

I, SI Vivekananda Halder of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 27.06.17 at 18.35 hrs in course of evening mobile duty received a telephonic information that one person namely Raju Santra (32) S/O- Lt. Ranajit of vill- Kamarda, PS- Nandakumar Dist- Purba Medinipur is running his clandestine business by selling I/D liquor at his shop unauthorized at Kamarda Bazar accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with force had been to Kamarda Bazar at 19.15 hrs and identified the shop of above accused person and found that he was selling I/D liquor. Accordingly we searched and found 10 Ltrs. Jaricane contains 06 Ltrs I/D Liquor (Cholai) and 06 bottles country spirit kept in his shop. On being asked he failed to produce any license/receipt/any other valid document in support of above quantities of liquors which he was selling unauthorizedly in his shop. So, I arrested him at 19.25 hrs and note here that he is a challenged person, having imputed left hand. After observing all formalities and seized the above quantities of liquor in presence of witnesses in between 19.15 hrs to 20.05 hrs after preparing proper Seizure list duly signed by accused person and witnesses and 375 ml liquor in a bottle and 01 bottle C.S has been taken as sample.

Under the above fact and circumstances I pray before you that a specific case may kindly be started against the accd. namely Raju Santra (32) S/O- Lt. Ranajit of vill- Kamarda, PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
