Sub:- Complaint against Sk Mustak Ahmed Sha S/o Abdur Rahaman Sha @ Banu Master vill- Gopalpur, PS- Mahishadal, Dist- Purba Medinipur for continuous conducting mischief to evict this Govt. Office from the land building.

I am submitted a complaint against one Sk Mustak Ahmed Sha S/o Abdur Rahaman Sha @ Banu Master vill- Gopalpur, PS- Mahishadal, Dist- Purba Medinipur of Nandakumar, PS- Nandakumar, Dist- Purba Medinipur. On the following allegation for taking lawful action against hom.

That since my joining this office, on 02.08.16 on posting vide DO No. Police West Bengal Org No. 328/ADGP (L&O)/PER/PER/GA-II Dated 27.07.2016 PER/GA II-207/13 (PT.II), the said Sk Mustak Ahmed Sah who is not concern with this rented building severally told me to leave this office and harassed me by obstructing road by putting sand, brick etc.

That he recently started a construction just behind my office on the same constructed building without asking me and from don to dusk the sound of hammering on the wall of this office caused a serious disturbance and sound pollution at this office.

That on 28.11.16 the delivery pipe of the rooftop water reservoir of this office has been intentionally damaged and cut out by him to stop the water supply at this office. He Caught red handed and later he arranged to repair the same. He along his father called at this office and asked me to shrift elsewhere, and vacant this office immediately.

On 23.01.2017 evening while my office stuffs are goes out, he & his labors cut out and stolen the entire water supply line of "Sajal Dhara Project" at the ground reservoir from where the same are pulling up to rooftop reservoir by Tulu pump, caused the entire reservoir dry, and an acute water crisis at this office was happened.

That, as it is a hired building to run a Govt. office of Circle Inspector Nandakumar and the actual owner are staying in Kolkata namely Md. Moshiar Rahaman Sah S/o. Noor Muhammad Sah of Gopalpur, PS- Mahishadal, Dist- Purba Medinipur A/P C/O DRAI Pvt. Ltd. Blaka Abasan, Flat No. C4/0-9, PO- Newtown, PS- Rajarhat, Kolkata 700156 and not looking after any welfare of this office. Sk Mustak Ahmed Sah who is not at all concern with this office shows his arrogance and rowdism towards the office of Circle Inspector, Nandakumar.

Being attached to law implementing agency I informed the matter to Hon'ble Superintendent of Police, Purba Medinipur and as per kind direction I am submitting the complaint for taking legal step against Sk Mustak Ahmed Sah, S/o Abdur Rahaman Sha @ Banu Master vill- Gopalpur, PS- Mahishadal, Dist- Purba Medinipur immediately and obliged.
