In producing herewith one arrested accused person namely 1) Arabinda Jana (48) S/O-Lt Gourhari Jana of Village Dakhin Narkalda PS Nandakumar Dist Purba Medinipur with seized articles 1) Ten (10) liters approx of I/D liquor (Cholai) in one Plastic Jar/Can under proper seizure list from the possession of arrested person. I SI Nira Pada Dolai of Nandakumar P.S do hereby ~~filed~~ ^{lodged} complaint to the effect that on 28.01.2017 at 17.35 hrs while myself along with Const. 1636 Bhuddadev jana Const 190 Kishin Kisku L / Const 1823 Sampa Kundu was performing mobile duty vide Nandakumar P.S. CC NO 246 / 2017 Date 28.01.2017 received a source information that one persons is selling I/D liquor, (Cholai) in his shop at Kamarda Bazar , under Nandakumar PS .After receiving such information I informed to O/C Nandakumar PS about the matter and as per his order myself along with force and LC reached at Kamarda Bazar at 18.55 hrs. and found that one (01) person is selling I/D liquor(Cholai) from his shop situated at Kamarda Bazar to the peoples and passersby. But on getting scent the arrival of police said I/D liquor (Cholai) seller tried to fled away . But we could managed and able to apprehend one persons 1) Arabinda Jana (48) S/O-Lt Gourhari Jana of Village Dakhin Narkalda PS Nandakumar Dist Purba Medinipur able to flee away from the shop. On interrogation he confessed his guilt and disclosed his identity as the owner of ID. Liquor selling Shop e ID. Liquor Shop. Accordingly we searched and found approx 10 Its I/D Liquor Containing one Plastic Jar/can is lying in his Shop. On being asked he disclosed above noted identity and on demand he failed to produce any valid license/documents/ challan in supports of such possession and selling of I/D liquor (Cholai) . Accordingly I seized the above noted articles after preparing proper seizure list duly signed by the witnesses and arrested person and took sample 375 ML I/D liquor as Sampale from seized articles and labeled also. I arrested the above noted accused person issued memo of arrest and also inform them ground of arrest. On interrogation the arrested 1) Arabinda Jana (48) S/O-Lt Gourhari Jana of Village Dakhin Narkalda PS Nandakumar Dist Purba Medinipur stated that he is the seller of I/D liquor(cholai), It is evident and crystal clear that the arrested accused person are seller of I/D liquor (Cholai) violating provision of section 46(A)(C) of Bengal Excise act. 1909. It is also revealed during enquiry that the said arrested person are selling the I/D , Liquor Choai to the public.

Under the above fact and Circumstances I pray before you that a specific case may kindly be started against the accused persons namely 1) Arabinda Jana (48) S/O-Lt Gourhari Jana of Village Dakhin Narkalda PS Nandakumar Dist Purba Medinipur along with above noted seized articles under proper section .of law and arrange for its investigation .
