In producing herewith two arrested accused namely (1) Astami Dinda (50) W/O Kartick Dinda 2) Nemai Giri S/O Lt Nagandra nath both of village Kalichak jalai, P.S.- Nandakumar, Dist- Purba Medinipur with seized articles-i.e (1) Ten [10] liters of I/D liquor in a plastic jarican, amount Rs 1250 /- (approx), (2) Eight (8) bottles of Thunderbolt Super strong beer 650ml each MRP Rs 70 each, (3) Two pieces (2) of Black label strong beer (650 ml each) MRP Rs 75 each, (4) five (05) Bottles Country Sprit (Power) (600) M.L each) MRP Rs 50 each; Total amounting Rs 250/- (approx), (5) Fermented Wash 35 ltrs, (6) Molasses 25 kg, (7) One Dirty Aluminium Hadi medium size, (8) Plastic funnel and (9) plastic pipe of length around 10 feet all these seized articles seems to be highly hazardous for human consumption,

I, beg to report that on 26.12.2016 at 14.15 hrs I, SI Samar Mishra received telephonic source information vide Nandakumar PS GDE No 1046 dtd 26.12.2016 to the effect that some person have gathered in one illicit liquor manufacturing unit cum selling shop at village - Kalichak jalai, PS Nandakumar. I informed to O/C Nandakumar PS about the matter and as per his order myself along with C-1541 Amit Das C- 124 Sandip Mohanty, NVF Dulal Mandal C L-1856 Joshna Gol Barman Vide Nandakumar PS CC No 3420 /2016 Dt 26.12.2016 left PS with govt vehicle no WB-30-C-9757 to work out the information and to nab the accused persons. On arrival at the spot at 15.25 hrs. I found that some persons are hiding in tiles shaded temporary I/D liquor manufacturing unit cum selling shop. I asked them to come out but they did not paid any heed to it. Later on police party entered into the shop and arrested above noted two accused persons found that the accused persons have fled from backdoor and it was found that illegal ID Liquor, Foreign liquor, Country Sprit etc are lying at the spot along with manufacturing articles in those shops.

On local enquiry it could be learn that the accd person (1) Astami Dinda (50) W/O Kartick Dinda 2) Nemai Giri S/O Lt Nagandra nath both of village Kalichak jalai, P.S.- Nandakumar, Dist- Purba Medinipur are the kingpins who run this illegal activity along with other localities: I seized those articles after preparing proper seizure list duly signed by the witnesses and also took samples of all the seized articles separately. This is to note here that the incident has already been communicated with excise department at Nandakumar. I destroyed (1) Fermented Wash 35 ltrs, (2) Molasses 25 kg, in the spot.

So I pray that necessary legal action may kindly be taken against the accused namely (1) (1) Astami Dinda (50) W/O Kartick Dinda 2) Nemai Giri S/O Lt Nagandra nath both of village Kalichak jalai, P.S.- Nandakumar, Dist- Purba Medinipur for manufacturing and selling poisonous I/D liquor, etc.
