In producing herewith one arrested accused person namely Gouri Sankar Bhowmick (40 yrs) S/O- Santosh Kumar Bhowmick of Vill- Changra Kalaganda PS- Tamluk Dist- Purba Medinipur along with following seized articles under proper seizure list-i) 25 litres of I/D liquor contained in one plastic jaricane ii) 375 ml ID liquor as sample in a bottle.

I, ASI Aminul Islam of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 08/02/17 at 18.35 hrs in course of evening mobile duty received a telephonic information that one person namely Gouri Sankar Bhowmick (40 yrs) S/O- Santosh Kumar Bhowmick of Vill- Changra Kalaganda PS- Tamluk Dist- Purba Medinipur is running his clandestine business by selling I/D liquor at his shop unauthorized at Dakshin Narikelda and accordingly I informed to O/C Nandakumar PS and as per his instruction I along with C/901 Susanta Panda C/190- Kishan Kisku had been to Dakshin Narikelda at 19.15 hrs vide C.C No.-342 dated 08/02/17 and identified the shop of above noted accused person and found that he was selling I/D liquor. Accordingly we searched and found 25 litres (Approx) of I/D liquor contained in one plastic jaricane kept in his shop. On being asked he failed to produce any license/receipt/any other valid document in support of above quantities of liquors which he was selling unauthorized in his shop. So, I arrested him after observing all formalities and seized the above quantities of liquor in presence of witnesses after preparing proper Seizure list duly signed by them and the accused person and 375 ml liquor has been taken as sample in a bottle.

Under the above fact and circumstances, I pray before your kind self that a specific case may kindly be started against Gouri Sankar Bhowmick (40 yrs) S/O- Santosh Kumar Bhowmick of Vill- Changra Kalaganda PS- Tamluk Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.


