Dear Sir,

I do here by lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against one Narayan Achar, S/O Lt. Mrityunjoy Achar, Vill: + PO: Khanchi, P.S.- Nandakumar Dist Purba Midnapur has committed theft in respect of Electricity U/S 135 of Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 14.02.2017 at about 2.05 PM I Sri Dibyendu Sekhar Bhunia, D.E. (S & LP) Purba Midnapur RM office along with Chandan Kr. Hudait, Sr. SAE(E), Nandakumar C.C.C., Rabindra Nath Adak, Sr. TSH, Tapan Kr. Adak, LM and other officials had been to the village Khanchi for inspection purpose of energy meter.

In course of inspection to the premises of Narayan Achar and it was found that the aforesaid person i.e. Narayan Achar bearing Consumer ID:222215242 and Meter no: L4605811 was consuming Electricity unauthorisedly by way of tampering of incoming service cable before entry into energy meter for less recording of energy to energy meter at the tune of load 1.18 KVA for his wrongful gain, causing loss of revenue to the WBSEDC.

As theft of electricity was detected at first we disconnected the service connection and removed the tampered portion of cable and then some portion of tampered PVC cable two core black colour (4 meter approx.) and also single core PVC wire yellow colour (1 meters appprox.) and also one yellow card Serial no: 1523254 in the name of Narayan Achar were seized under a memo of Seizure list, in presence of witnesses and also the consumer Narayan Achar and their signature were duly obtained on the seizure list. The said seizure articles were duly packed and leveled at the inspection site and the signature of the witnesses also obtained on the packet and level. I also prepared an inspection report in the presence of witnesses and accused Narayan Achar and duly signed on it by them. After completion of formalities of the inspection, the inspection team left the premises at 2.30 P.M.

Thus the accused Narayan Achar, S/O Lt. Mrityunjoy Achar, Vill: + PO: Khanchi, P.S.- Nandakumar Dist Purba Midnapur has committed an offence under section 135 (i)(b) of Electricity Act 2003 read with Amendment 2007 for commission of theft in respect of theft of power.

So you are requested to take cognizance of this complaint and treat it as FIR.
