Sir,

In producing herewith one arrested accused person namely Uttam kr Jana (30yrs) S/O-Swapan kr Jana of vill- Tikarampur PS- Nandakumar Dist- Purba Medinipur along with following seized articles under proper seizure list-1) 10 bottle Country spirit (Sun) each 600ml.

I, SI Nirapada Dolai of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 15.02.17 at 14:35 hrs in course of evening mobile duty received a telephonic information that one person namely Uttam kr Jana (30yrs) S/O-Swapan kr Jana of vill-Tikarampur PS- Nandakumar Dist- Purba Medinipur is running his clandestine business by selling Country Spirit at his selling shop unauthorized at Babartyarhat and accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with C/402-Sukumar Maity, NVF-Dulal Mondal vide Nandakumar PS C.C. No-409 dated 15.02.17 had been to Babartyarhat at 16:30 hrs and identified the shop of above accused person and found that he was selling Country Spirit. Accordingly we searched and found 10 bottle Country Spirit (Sun) kept in his shop. On being asked he failed to produce any license/receipt/any other valid documents in support of above quantities of liquors which he was selling unauthorized in his shop without any valid documents. So, I arrested him after observing all formalities and seized the above quantities of liquor in presence of witnesses after preparing proper seizure list duly signed by them and the accused person and 600 ml liquor has been taken as sample in a bottle.

Under the above fact and circumstances I pray before your kind self that a specific case may kindly be started against namely Uttam kr Jana (30yrs) S/O- Swapan kr Jana of vill- Tikarampur PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
