Sub. : F.I.R. against unauthorized seller of liquors.

Sir,

In producing herewith the arrested accused person namely Sri Kalipada Mondal (36) @ Bapi S/O- Bijay Mondal of Dorichak, PS Nandakumar, Dist. Purba Medinipur along with 06 (Six) bottles Country Spirit each of 600ml, I ASI Bablu Dolai of Nandakumar PS do hereby lodge complaint against the above noted arrested accused person to the effect that today on 21.02.17 at 14:05 hrs, I along with C/1532 Jagai Duley, NVF Dulal Mondal both of Nandakumar PS left for mobile duty at PS area vide Nandakumar PS GDE No. 973, dt. 21.02.17. CC NO 467/17 Dt. 21.02.17. During mobile duty on 21.02.17 at about 20:05 hrs found that the above noted accused person was selling liquors to the different customers from his shop at Thekua Bazar under Nandakumar PS. On seeing Police above noted person tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On ask, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing / selling of alcoholic liquors and any paper regarding possession of such quantity of alcoholic liquors. So, I arrested the above noted accused person on 21.02.17 at 20:15 hrs and below noted quantity of alcoholic liquors were seized from his possession under proper seizure list duly signed by the witnesses on 21.02.17 in between at 20:25 hrs to 20:35hrs.

Description of the seized items:

iii. 06 (Six) bottles Country Spirit each of 600ml.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So, I pray that a specific case may kindly be started against the arrested accused person namely Sri Kalipada Mondal (36) @ Bapi S/O- Bijay Mondal of Dorichak, PS Nandakumar, Dist. Purba Medinipur, U/S 46A(c) of Bengal Excise Act-1909.
