In producing herewith arrested accused persons namely 1) Sikandar Yadav, s/o- Nami Yadav of vill- Solarkurd, PO-Paikulibodha, PS- Phulwaira, Dist. Gopalganj, Bihar and 2) Balistar Yadab, s/o- Kameswar Yadab of vill- Nadoa, PO- Jagdari Banakta, PS- Bhora, Dist.- Gopalganj, Bihar both presently residing at Madhabpur beside NH-41 under Nandakumar PS along with seized articles i.e i) 04 (four) nos. of iron made barrels loaded with petroleum product each capacity of 200 (two hundred) Itrs total approximately 800 (eight hundred) Ltrs. and ii) 01(one) Ltr of petroleum product taken from the above

barrels as sample for its examination and opinion.

I SI, Nirapada Dolui of Nandakumar PS, Dist- Purba Medinipur do hereby lodged a written complaint against the accused persons namely 1) Sikandar Yadav, s/o- Nami Yadav of vill- Solarkurd, PO- Paikulibodha, PS- Phulwaira, Dist. Gopalganj, Bihar and 2) Balistar Yadab, s/o- Kameswar Yadab of vill- Nadoa, PO- Jagdari Banakta, PS- Bhora, Dist.-Gopalganj, Bihar both presently residing at Madhabpur beside NH-41 under Nandakumar PS to the effect that today (23.02.2017) at 17.25 hrs. myself received a source information regarding illegal/clandestine business, storing and selling illegally in respect of petroleum product is running near. Madhabpur, beside NH-41. under Nandakumar PS. After receiving such information, myself informed to O/C, Nandakumar PS . Thereafter OC Nandakumar PS informed the matter to Dy SP DEB, Purba Medinipur for taking necessary action. Then DEB officers and force came to Nandakumar PS. As per instruction, myself along with C/ 124 Sandip Mahanty, C/782 Deb Kr. Singha of Nandakumar PS accompanied with SI B.D.Banerjee, ASI/Tapas Paul, WC/291 Rabindra Nath Bari, WC/287 Indrajit Das of DEB, Purba Medinipur left for P.O to work out the information after noting. In the matter in. Nandakumar. P.S. GDE NO. 1067 dt. 23.02.2017. At 18.40 hrs. when we reached at the P.O, we found some persons are selling petroleum products from the barrels which are lying there in a makeshift godown. On a hot chase we are managed to apprehend two persons other miscreants managed to fiee away from there. On interrogation the apprehended persons disclosed their identity namely 1) Sikandar Yadav, s/o- Nami Yadav of vill- Solarkurd, PO- Paikulibodha, PS- Phulwaira, Dist. Gopalganj, Bihar and 2) Balistar Yadab, s/o- Kameswar Yadab of vill- Nadoa, PO-Jagdari Banakta, PS- Bhora, Dist.- Gopalganj, Bihar both presently residing at Madhabpur beside NH-41 under Nandakumar PS. On being asked them to produce valid papers / license from the competent authority in support of such business as well as storing and selling of the petroleum product, but they failed to produce any paper in support of such business. Accordingly, after lapse of reasonable time in presence of available witnesses namely 1) Tarapada Das, s/o- Madhusudan Das of Madhabpur, PO- Kalyanpur, PS- Nandakumar and 2) Manish Kumar s/o- It. Promodh Kumar of vill- Panchur, PS-Laxmanjhola, Dist. Pari, Himachal Pradesh, presently residing at Madabpur under Nandakumar PS, the following articles seized after observing all formalities under proper seizure list duly signed by the witnesses and accuseds and copy of seizure list also serve to the arrested person and took signature on label. Seized articles are as follows i) 04 (four) nos. of iron made barrels loaded with petroleum product each capacity of 200 (two hundred) ltrs total approximately 800 (eight hundred), and ii) 01(one) Ltr of petroleum product taken from the above barrels as sample for its expert opinion. The seized articles kept at

On interrogation the apprehended persons confessed that they are running the said business without any valid license/documents. As such I arrested above noted persons issuing memo of arrest duly signed and inform them ground of arrest, as they are violated section 3(d) of Essential Commodities Act X/55 and they are liable for prosecution under section7(i)a(ii) of Essential Commodities Act X/55.

Thereafter we returned at PS along with arrested accused person and seized articles, I am submitting a written complaint to start a specific case against the persons namely 1) Sikandar Yadav, s/o- Nami Yadav of vill- Solarkurd, PO-Paikulibodha, PS- Phulwaira, Dist. Gopalganj, Bihar and 2) Balistar Yadab, s/o- Kameswar Yadab of vill- Nadoa, PO- Jagdari Banakta, PS- Bhora, Dist.- Gopalganj, Bihar both presently residing at Madhabpur beside NH-41 under Nandakumar PS under proper section of law and arranging its investigation.
