In producing herewith one Female arrested accused person namely Malina Samanta(50yrs) W/O-Khudiram Samanta of vill-Bar-bahichberia PS- Nandakumar Dist- Purba Medinipur along with following seized articles under proper seizure list-1) 07 ltr I/D Liquor Containing in one Plastic Jaricane.

I, SI Vivekananda Halder of Nandakumar PS do hereby lodged a written complaint against the above noted female accused person to the effect that today 20.03.17 in course of my evening mobile duty received a telephonic information that one person namely Malina Samanta(50yrs) W/O-Khudiram Samanta of vill-Bar-bahichberia PS- Nandakumar Dist- Purba Medinipur is running her clandestine business by selling of I/D Liquor at her house at village Bar-bahichberia and accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with C/781-Anshuman Sahani , Const-124-Sandip Mahanti and L/C-1823-Sampa Kundu vide Nandakumar PS GDE No-881 dated 20.03.17 had been to Vill-Bar-bahichberia at 16:35 hrs and identified the house of above accused person and found that She was selling I/D Liquor. Accordingly I searched and found 10 ltr One Plastic Jaricane in which 07 ltr I/D Liquor (Approx). On being asked She failed to produce any license/receipt/any other valid documents in support of above quantities of liquors which She was selling unauthorised at her shop without any valid documents. So, I arrested her with the help of L/C-1823-Sampa Kundu after observing all formalities and seized the above quantities of liquor in presence of witnesses after preparing proper Seizure list duly signed by them and the accused person and 375 ml I/D liquor has been taken in a bottle as sample & Label also

Under the above fact and circumstances I pray before your kind self that a specific case may kindly be started against the arrested accd person namely Malina Samanta(50yrs) W/O-Khudiram Samanta of vill-Barbahichberia PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
