Sir,

In producing herewith one arrested accused person namely Ashok kr Maity (29) S/O-Dilip kr Maity of vill-Louhajang PS- Nandakumar Dist- Purba Medinipur along with following seized articles under proper seizure list- 1) 10 ltr I/D Liquor Containing in one Plastic Jaricane.

I, SI Bhabani Prasad Mukhopaddhay of Nandakumar PS do hereby lodged a written complaint against the above noted accused person to the effect that today 22.03.17 in course of my evening mobile duty received a telephonic information that one person namely Ashok kr Maity (29) S/O-Dilip kr Maity of vill-Louhajang PS- Nandakumar Dist- Purba Medinipur is running his clandestine business by selling of I/D Liquor at his selling shop at Bhabanipur and accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with C/402-Sukumar Maity, Const-1231-Shyampada Purakait vide Nandakumar PS GDE No-972 dated 22.03.17 had been to Bhabanipur at 20:05 hrs and identified the selling shop of above accused person and found that he was selling I/D Liquor. Accordingly we searched and found 10 ltr I/D Liquor Containing in One Plastic Jaricane (Approx). On being asked he failed to produce any license/receipt/any other valid documents in support of above quantities of liquors which he was selling unauthorised at his shop without any valid documents. So, I arrested him after observing all formalities and seized the above quantities of I/D liquor in presence of witnesses after preparing proper Seizure list duly signed by them and the accused person and 375 ml I/D liquor has been taken in a bottle as sample & Label also

Under the above fact and circumstances I pray before your kind self that a specific case may kindly be started against the arrested accd person namely Ashok kr Maity (29) S/O-Dilip kr Maity of vill-Louhajang PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
