Sir,

In producing herewith the accused person namely Asish Guria (52), S/O - Sripati Charan Guria of Vill. - Kandapasra, PS - Nandigram, Dist. - Purba Medinipur under arrest along with following seized articles as per seizure list and relevant documents. I ASI Amitava Mukherjee attached with Nandigram PS Dist. Purba Medinipur do hereby lodged a written complaint against the above noted accused person as suomoto to the effect that today (26.12.16) at 19:15 hrs in course of mobile duty received information that one person is selling I.D liquors near Nandigram BMT High School (Boys) under Nandigram P.S. Then I informed the officer in charge of Nandigram PS and as per order of OC Nandigram PS I along with C/506 Monirujjaman Mandal , C/893 Ashis Biswas both of Nandigram PS left for Nandigram BMT High School (Boys) to work out the information. We reached at BMT School at about 19:40 hrs. and found the above noted accused person is selling I.D liquor in an open place beside the West Side of School. Then we came close to the spot and all the customers successfully fled away and we able to intercept the above noted accused person . On demand the accused person failed to produce any valid license/documents in favour of such business and possession of I.D liquor. On interrogation the above noted accused person confessed his guilt. As the said accused person such possession of I.D liquor having no license. He is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So he committed an offence U/S 46A(c) B.E. Act of 1909. So I arrested him and seized 1(one) 05 Lts Jar cane containing 04 Litters (Approx) I.D Liquors (value - Rs 400 (Approx) from his possession after preparing seizure list with label duly signed by the witnesses and the accused person with (1) one 375 ML bottle containing such I.D liquor collected from that Jar cane as sample with label.

The incident has already been communicated with excise department at Nandigram Circle.

I therefore pray that a suitable case may be initiated against the above noted accused person under proper section of law.
