Sir,

In producing herewith ~~two~~ ^{one} arrested accused person namely Saraswati Adhikary (55 yrs) W/O- Nandalal adhikary of Vill- Chaksimuliya PS- Nandakumar Dist- Purba Medinipur along with following seized articles under proper seizure list—i) 20 litres of I/D liquor contained in one plastic jaricane ii) 375 ml ID liquor as sample in a bottle.

I, ASI Anil Kr Dey of Nandakumar PS do hereby lodge a written complaint against the above noted accused person to the effect that today 17/12/16 at 14.55 hrs in course of evening mobile duty received a telephonic information that one person namely Saraswati Adhikary (55 yrs) W/O- Nandalal adhikary of Vill- Chaksimuliya PS- Nandakumar Dist- Purba Medinipur is running her clandestine business by selling I/D liquor at her shop cum house unauthorized at Chaksimuliya and accordingly I informed to O/C Nandakumar PS and as per his instruction myself along with C/402- Sukumar Maity, C/1231- Shyampada Purkait and L/C- 656- Mousumi Barman had been to Chaksimuliya at 15.35 hrs vide C.C No.- 3951/16 dated 17/12/16 and identified the shop of above accused person and found that she was selling I/D liquor. Accordingly we searched and found 20 litres (Approx) of I/D liquor contained in one plastic jaricane kept in her shop. On being asked she failed to produce any license/receipt/any other valid document in support of above quantities of liquors which she was selling unauthorizedly in their shop. So, I arrested her with the help of L/C- 656- Mousumi Barman after observing all formalities of arrest and seized the above quantities of liquor in presence of witnesses after preparing proper Seizure list duly signed by them and the accused person and 375 ml liquor has been taken as sample in a bottle.

Under the above fact and circumstances, I pray before you that a specific case may kindly be started against one arrested accused person namely Saraswati Adhikary (55 yrs) W/O- Nandalal adhikary of Vill- Chaksimuliya PS- Nandakumar Dist- Purba Medinipur along with above noted seized articles under proper section of law and arrange for its investigation.
