Sub: - Complaint for possession of I/D liquor without any license.

In producing hisewith one accused person namely Sk Manik Chand (27 Year) s/O-Li Sk. Eyasin of Kanakpur (Ward No-2) PS-Panskura Dist-Purba Mcdinipur along with the below noted seized items under proper seizure list and relevant memos and I beg to state that today on 10.03.2017 at 03.25 hrs myself received a secret source information that one person named as Sk Manik Chand was running a business of selling of I/D liquors to different persons from his house. To pursue the information myself PSI Qumar Hasheed along with C/886 Nemai Patra and C/1145 Basudeb Rana left for village Rajhati. I reached at Kanakpur at 04.05 hrs and as pointed by my source we cordoned the said house, seeing the police party the I/D liquors seller tried to flee way but we managed to apprehend him, who was selling liquors from his house. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched his house and below noted quantity of I/D liquors was found from his possession at his house. On enquiry it was known said SK Manik Chand was running the businesses of selling of I/D liquors liquor since last few months. On demand he failed to produce any license for possession and selling of liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 04.25 hrs to 04.35 hrs on 10/03/17.

Description of the seized items:-1] I/D liquor contained in one 05 ltrs plastic jerrican, approx 04 ltrs of I/D liquor and also took 375 ml of I/D liquors in a bottle as sample.

I arrest him at 04.35 hrs on 10.03.17 and brought him to PS and on return to PS and I submit this complaint to start case against him U/S 46 A(c) of B.E Act .On arrest, all arrest formalities maintained and inform his family members regarding arrest.
