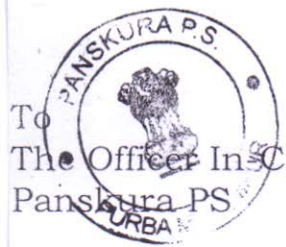

Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Prahallad Ch. Paik (45Year) S/O- Lt. Nitai Ch. Paik of Bararpota, PS-Panskura Dist-Purba Medinipur along with the below noted seized items under proper seizure list and relevant memos and I beg to state that today on 11.03.2017 at 18.25 hrs myself received a secret source information that one person named as Prahallad Ch. Paik was running a business of selling of I/D liquors to different persons from his house. To pursue the information myself ASI Dilip Chakraborty along with C-1194 Birandranath Maity and C/861 Goutam Chakraborty left for village Baharpota. I reached at Baharpota at 19.45 hrs and as pointed by my source we cordoned the said house - cum Vegetables shop and I/D Liquor Shop , seeing the police party the I/D liquors seller tried to flee way but we managed to apprehend him, who was selling liquors from his said shop. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched his house and below noted quantity of I/D liquors was found from his possession at his said shop. On enquiry it was known said Prahallad Ch. Paik was running the businesses of selling of I/D liquors liquor since last few months. On demand he failed to produce any license for possession and selling of liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 1 hrs to 19.55 to 20.05 hrs on 11/03/17.

Description of the seized items:-1) I/D liquor contained in one 05 ltrs plastic jerrican , approx 04 ltrs of I/D liquor and also took 375 ml of I/D liquors in a bottle as sample.

I arrest him at 20.05 hrs on 11.03.17 and brought him to PS and on return to PS and I submit this complaint to start case against him U/S 46 A(c) of B.E Act .On arrest, all arrest formalities maintained and inform his family members regarding arrest.
