I do hereby lodge complaint empowered by the Electricity Act, 2003 to the effect that Sri Ajit Duari, S/O- Lt. Sudhir Duari, Village- Basantabari, P.O- Dhuliapur, PS- Panskura, Dist- Purba Medinipur has committed theft of electricity U/S 135 of the E. Act. 2003 read with Amendment Act, 2007 at village Amdubi.

On 14.03.2017 at about 12:00 pm, I Sri Uttiya Roy Chowdhury, AE & SM. Gourangapur Customer Care Centre along with (i) Sri Anil Kr. Dolui, Hg. Sr. LM, Gourangapur C.C.C., (ii) Sri Lal Mohan Chakraborty, Hg. TSH, Gourangapur C.C.C. went to the Agriculture(Rural) field of Ajit Duari, S/O- Lt. Sudhir Duari, Village- Amdubi, PS- Panskura, Dist- Purba Medinipur and found that he was consuming electricity dishonestly by the way of direct hooking from the nearest L.T.O.H. mains of WBSEDCL at the same area. As theft of electricity was detected during the inspection some portion of PVC Alm. wire with hooking device was seized in presence of the witnesses and their signatures obtain on the seizer list. The seized article are duly packed, sealed & labeled at the inspection site and signatures of the witnesses obtain on the sealing label. On spot the accused was not found and on query it is learnt the Sri Ajit Duari, S/O- Lt. Sudhir Duari is a residential of Village- Basantabari, P.O Dhuliapur, PS- Panskura, Dist- Purba Medinipur.

The inspection team left the aforesaid premises i.e the Agriculture field of Sri Ajit Duari, S/O- Lt. Sudhir Duari, Village- Amdubi on 14.03.2017 at about 12:20 pm.

Thus Sri Ajit Duari, S/O- Lt. Sudhir Duari, Village- Basantabari, P.O- Dhuliapur, PS- Panskura, Dist- Purba Medinipur has committed an offence U/S 135(1) (a) of E. Act, 2003 read with Amendment Act, 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R.
