I do hereby lodged written complaint, empowered by the electricity act 2003 read with amendment act 2007 against 1) Niranjana Samanta S/O Lt Basudeb Samanta, VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur, 2) Nikunja Samanta S/O Lt Basudeb Samanta VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur 3) Mukunda Samanta S/O Lt Basudeb Samanta VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur for commission of theft in respect of electricity u/s 135 (1)(b) electricity act 2003 and amendment act 2007 which stated here under.

Today i.e. 16.03.2017 at around 02:50 pm. I Shri Surya Prakash Singh, AE & SM, Panskura CCC, WBSEDCL along with 1) Shri Sisir Majumder, SAE, Panskura CCC, Panskura CCC, 2) Shri Musfakur Rahaman, LM, Panskura CCC & Other officials had been to the village Uttar Jianda for inspection purpose. At first we arrived in the domestic premises of Niranjana Samanta S/O Lt Basudeb Samanta, VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur. During inspection it was found that Niranjana Samanta has got one electric connection vide contract account no. - 201471326 and meter no. - TA150832 instead of that he was consuming electricity dishonestly through direct hooking from nearest L.T. Line to run his domestic premises in view of less recording of energy unit into the energy meter for bypassing of meter for his wrongful gain causing loss of revenue of WBSEDCL at the tune of load 1 KW.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the unauthorized hooking wire from L.T.mains and then some portion of single core pvc wire blue colour with hooking device 4 meters approximate was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials was duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 03:05 pm.

In course of holding further inspection in second phase myself along with my above mentioned team I also visited the domestic premises of one Nikunja Samanta S/O Lt Basudeb Samanta VILL- Uttar Jianda on the same date i.e. 16.03.2017 at around 03:06 pm. During inspection it was found that Nikunja Samanta has got one electric connection vide contract account no. - 201578634 and meter no. - TA401009 instead of that he was consuming electricity dishonestly through direct hooking from nearest L.T. Line to run his domestic premises in view of less recording of energy unit into the energy meter for bypassing of meter for his wrongful gain causing loss of revenue of WBSEDCL at the tune of load 1.5 KW.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the unauthorized hooking wire from L.T.mains and then some portion of single core, pvc wire 1 Nos black colour with hooking device 4 meters

approximate was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials was duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 03:22 pm.

In course of holding further inspection in third phase myself along with my above mentioned team I also visited the domestic premises of one Mukunda Samanta S/O Lt Basudeb Samanta VILL- Uttar Jianda on the same date i.e. 16.03.2017 at around 03:23 pm. During inspection it was found that Mukunda Samanta has got one electric connection vide contract account no. - 222093738 and meter no. - ML524994 instead of that he was consuming electricity dishonestly through direct hooking from nearest L.T. Line to run his domestic premises in view of less recording of energy unit into the energy meter for bypassing of meter for his wrongful gain causing loss of revenue of WBSEDCL at the tune of load 1 KW.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the unauthorized hooking wire from L.T.mains and then some portion of single core, pvc wire 1 No grey colour with hooking device 5 meters approximate was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials was duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 03:38 pm.

All the premises are situated side by side in the same building.

Thus the accd. Persons 1) Niranjana Samanta S/O Lt Basudeb Samanta, VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur, 2) Nikunja Samanta S/O Lt Basudeb Samanta VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur 3) Mukunda Samanta S/O Lt Basudeb Samanta VILL- Uttar Jianda, P.S.- Panskura, Dist- Purba Medinipur have committed theft in respect of electricity unauthorizedly for domestic purpose.

Hence you are requested to take cognizance on the illegal act of the accd. persons under the per view of electricity act 2003 read with amendment act 2007 u/s 135 (1) (b) of the said act and treat the same as FIR.


