Sir,

I do hereby lodge written complaint, empowered by the Electricity Act 2003 read with Amendment Act 2007 against Badal Chandra Das S/O Lt Amulya Das; Bakulda; P.S.- Panskura, Dist- Purba Medinipur, for commission of theft in respect of electricity u/s 135 (1) (b) of Electricity Act 2003 and Amendment Act 2007 which stated here under.

Today i.e. 23.03.2017 at around 11:10 am. I Surya Prakash Singh AE (E), Panskura CCC, WBSEDCL along with 1) Sisir Majumder, SAE, Panskura CCC 2) Mr. Tirthankar Sarkar, SE(S&LP), Vidyut Bhavan, Kolkata 3) Mr. Bappaditya Samanta, AE(S&LP), Vidyut Bhavan, Kolkata 4) Mr. T.N. Masanta, Special Officer, (S&LP), Vidyut Bhavan, Kolkata 4) Mr. J.S. Neogi, Special officer (S&LP), Purba Medinipur region, 5) Fatik Seth, Hg SR LM, Panskura CCC 6) Musfakur Rahaman, LM, Panskura CCC & Other officials had been to the village Bakulda for inspection purpose. At first we arrived in the STW premises of Badal Chandra Das S/O Lt Amulya Das, Vill - Bakulda, P.S.- Panskura, Dist- Purba Medinipur. During inspection it was found that Badal Chandra Dasha got one electric connection vide contract account no. - 222094429 and meter no. - YX005322 instead of that he was consuming electricity dishonestly through direct hooking from nearest L.T. Line using three core, PVC wire red, yellow, green colour with hooking device bypassing the energy meter in his STW premises in view of less recording of energy unit into the energy meter thereby causing less recording of energy in the installed meter for his wrongful gain and thus WBSEDCL losses revenue. As per physical inspection the load was found to be 5.9 Kva.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the unauthorized hooking wire from L.T. mains and then some portion of three core, PVC wire Red, yellow, green colour with hooking device 5meters approximate was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials were duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 11:30 am.

Thus the aforesaid accd. Person namely Badal Chandra Das S/O Lt Amulya Das; Bakulda; P.S.- Panskura, Dist- Purba Medinipur has committed theft of electricity unauthorisely for STW purpose and thereby he is liable to be prosecuted u/s 135 (1)(b) of Electricity Act 2003 read with Amendment Act 2007

Hence you are requested to take cognizance against the accd. person treating this complain as FIR.

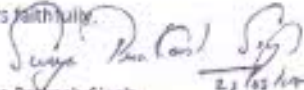

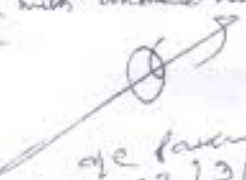
