I do hereby lodge written complaint, empowered by the Electricity Act 2003 read with Amendment Act 2007 at Sahadeb Majhi S/O Lt Bejoy Majhi; Parmanandapur, P.S.- Panskura, Dist- Purba Medinipur, for commission of theft of electricity u/s 135 (1) (b) of Electricity Act 2003 and Amendment Act 2007 which stated here under, i.e. 23.03.2017 at around 02:15 pm, I Dibyendu Sekhar Bhunia, DE(S&LP), Purba Medinipur Region, Tamruk along with 1) Surya Prakash Singh, AE & SM, Panskura CCC 2) Mr. Tirthankar Sarkar, SE(S&LP), Vidyut Bhavan, Kolkata 3) Mr. Pradya Samanta, AE(S&LP), Vidyut Bhavan, Kolkata 4) Mr. T.N. Masanta, Special Officer, (S&LP), Vidyut Bhavan, Kolkata 4) Mr. J.S. Neogi, Special officer (S&LP), Purba Medinipur region, 5) Fatik Seth, Hg SR LM, Panskura CCC 6) Mr. Kur Rahman, LM, Panskura CCC & Other officials had been to the village Parmanandapur for inspection purpose. When we arrived in the STW premises of Sahadeb Majhi S/O Lt Bejoy Majhi, Vill - Parmanandapur, P.S.- Panskura, Dist- Medinipur. During inspection it was found that Sahadeb Majhi has got one electric connection vide contract no. - 222032154 and meter no. - RSK 39233 instead of that he was consuming electricity dishonestly through hooking from nearest L.T. Line using single core, PVC wire green colour 3 no.s with hooking device bypassing the meter in his STW premises in view of less recording of energy unit into the energy meter thereby causing less recording of energy in the installed meter for his wrongful gain and thus WBSEDCL losses revenue. As per physical inspection the load was found to be 4.39 Kva.

As theft of electricity was detected during the inspection at first we disconnected the service connection, and the unauthorized hooking wire from L.T. mains and then some portion of single core, PVC wire 3 no.s green with hooking device 5meters approximate was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials were duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 02:40 pm.

The aforesaid accd. Person namely Sahadeb Majhi S/O Lt Bejoy Majhi; Parmanandapur, P.S.- Panskura, Dist- Purba Medinipur has committed theft of electricity unauthorisely for STW purpose and thereby he is liable to be prosecuted u/s 135(1)(b) of Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance against the accd. person treating this complain as FIR.
