Sir,

With profound grief and humble submission I, the undersigned beg this respectfully to submit the facts as stated hereunder for your kind consideration and necessary action please.

As a bonafide Indian citizen as well as B.P.L. member of the community I beg to submit that the Land in question as mentioned in schedule which your petitioner possessed since 30 (thirty) year without any uninterrupted hindrance and the land as described in schedule has been recorded as "vested Land" under L.R. Khatian No. 1 of mouza Kalidan, P.S. Panskura - I, appertaining to an area 14 dec.

That your petitioner has been possessing the Land in question in plot no. 1174 (L.R.) of mouza - Kalidan, area 04 dec. out of 14 dec. and in plot no. 1174/2753 area 02 dec. which is possessed by your petitioner since 30 years.
