In producing herewith arrested persons namely 1) Amit Achariya aged 24 years s/o- Anil Achariya of Nandigram PS Do, Dist- Purba Medinipur A/P, Naranda under Panskura PS and 2) Saddam Mallik aged 23 years s/o- Joynal Mallik of Talbagan (Ward no-06) PS- Rabindranagar Kolkata-66, in custody along with seized one pick-up van bearing Regd no- WB-29A/6826 and six numbers of cow.

I, S.I. Raban Hembram of Panskura PS do hereby lodged a written complaint against the above noted persons to the effect that in the night of 07/08.01.17 myself along with C/- 911, Shanku Mondal, C/- 1562, Anup Sing and C/- 1194, Birendranath Maity and on 08.01.17 at about 08:05 hrs we found one vehicle (pick up van) bearing Regd. no- WB-29A/6826 loaded with six numbers of cow was proceeding towards Kolkata on NH-06, which was suspicious manner. On perception we chased and challenged the driver of said vehicle and managed to detain them at Dhuliara under Panskura PS. On being asked they failed to explain how they have collected the six numbers of cows and failed to produced any documents/challan/receipt in support of loaded six number of cows so it was strongly been suspected that these cows were have been obtained either by theft or by fraudulently or dishonestly.

Accordingly, I seized the vehicle no WB-29A/6826 and loaded with six numbers of cows in between 10:45 hrs to 11:45 hrs under proper seizure list duly signed by the witnesses. Theafter I interrogated the above noted two arrested persons. On interrogation they admitted that the seized six cows are stolen cows and also told that the above noted persons and 3/4 others have committed theft of seized six cows from different villages under Panskura PS in the night of 07/08.01.17 and also stated that they are habituated theft of cows and dealing in the business of selling stolen cows.

So, I arrested the persons namely 1) Amit Achariya aged 24 years s/o- Anil Achariya of Nandigram PS Do, Dist- Purba Medinipur A/P, Naranda under Panskura PS and 2) Saddam Mallik aged 23 years s/o- Joynal Mallik of Talbagan (Ward no-06) PS- Rabindranagar Kolkata-66 at 12:05 hrs after observing all procedure and beg to lodged written complaint against them and their associates with a prayer for starting a case u/s- 413/414 I.P.C. against them.
