Sir,

I, S.I. Shabuddin Ali Khan of Panskura PS, do hereby lodged a written complaint against the following persons to the effect that, on 14.04.17 at about 20:55 hrs an information was received by a person over phone who refused to disclose his identity that, one person have been detained at 'Charak Mela' suspiciously as a thief, organized by the villagers of Usatpur village under Panskura PS Dist. Purba Medinipur. Huge people are assembled there and tension prevailing in the locality and recovery of detained person is urgently required. So, the matter was noted in G.D.E. vide Panskura PS G.D.E. No. 1123 dtd. 14.04.17 and as per your kind instruction myself and A.S.I./105, Prabir Saha, A.S.I./76, Sudhangshu Samanta, C/-911, Shanku Mondal, and other available forces all of Panskura PS, vide Panskura C.C. No. 1299 dtd. 14.04.17 had been to Usatpur village to work out the such information.

At about 21:35 hrs on same day we arrived the P.O. and found that, about 150/200 local villagers of Usatpur village including the villagers of neighbor villages were resent there with violent mood and they assaulted the suspected thief with intent to kill him. We tried to rescue him from the grab of public but local people obstructed, attacked and assaulted us by lathi, fist and blows with intent to kill us and they used criminal force to deter the public servant from discharging of our Govt. duty. Thereafter the matter was brought to the notice of O/C for reinforcement. About 22:15 hrs sufficient officer and forces arrived at P.O. and after their arrival we could able to rescue the suspected thief who received grievous injuries on his person due to manhandling by the public. The injured suspected thief has been admitted to Panskura S.S. Hospital at Pitpur form where he referred to Dist. Hospital, Purba Medinipur at Tamluk where he is in serious condition. He has been identified as Sk Atabul aged about 30 years S/O- Sk Hatem Vill+ P.O.- Dhekua PS- Sutahata Dist- Purba Medinipur.

During enquiry it came to light that, the following persons used criminal forces to the police personnel with violent mood and they assaulted the police personnel by fist, kicks, and lathi and by throwing brick bats with intent to kill us. Resulting myself, other officers and forces of Panskura PS received injuries and treated from Panskura S.S. Hospital at Pitpur.

So, I beg to pray that, a case may kindly be recorded against the following persons and others under proper section of law.
