Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Uttam Hembram aged about 52 years S/O- Lt Narayan Hembram of Haur PS Panskura Dist Purba Medinipur along with the below noted seized items, I SI Raban Hembram of Panskura PS beg to state that today on 12.01.17 Myself along with C/ 1364 Sunil Maji and C/1194 Birendranath Maity was a evening mobile duty and at about 16:35 hrs received a secret source information over phone that one person named as Uttam Hembram was running a business of selling of I/D liquors to different persons from his house situated at Haur. So, to pursue the information I had been to village Haur identified the house of Uttam Hembram who was selling I/D liquors. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, we held raid there and managed to detained the ID liquors seller and on searching his house below noted quantity was found On demand he failed to produce any license for possession of the I/D liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 17:35 hrs to 17:55 hrs on 12.01.17. Description of the seized items:-1) I/D liquor contained in one 05 lts. Plastic jarican containing approximately 04 lts., from the above mentioned seized item. I arrest him at - 17:55 hrs after observing all formalities.

Hence I pray that specific case may kindly be started against Uttam Hembram aged about 52 years S/O- Lt Narayan Hembram of Haur PS Panskura Dist Purba Medinipur under proper section of law of possession of the I/D liquors.
