Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Laltu Ghorai(29) S/O- Ranjit Ghorai of Suranankar, PS Panskura, Dist Purba Medinipur along with the below noted seized items, I ASI Sudhangshu Samanta of Panskura PS beg to state that on my Special Raid duty at PS area on 14.01.17 at about 17.45 hrs, received a secret source information that, one person named as Laltu Ghorai running a business of selling of I/D liquors to different person at Road Side of Suranankar under Panskura PS. To pursue the information myself along with C/ 293 Sankar Neogi and C/641 Avijit Das left for Suranankar after having inform to OC, Panskura PS. I reached at Suranankar at 18.05 hrs and as pointed by my source we cordoned the road side area at suranankar where Laltu Ghorai was selling I.D liquor, seeing the police force the persons purchasing the I/D liquors managed to run away but we managed to apprehend the above named Laltu Ghorai, who was selling I/D liquors. We approached local people to witness the search and seizure but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched him and below noted quantity of I/D liquor was found from the bag on his possession. On enquiry it was known he was running the businesses of selling of I/D liquor since last few days. On demand he failed to produce any license for possession of the I/D liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 18.05 hrs to 18.25 hrs on 14.01.17. Description of the seized items:-1) I/D liquor contained in one 5 ltrs. Plastic jarican containing approximately 04 lts. 2) I also took 375 ml of ID liquor in a bottle as sample, from the above mentioned seized item. I arrest him at 18.25 hrs on 14.01.17 and brought him to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against him U/S 46 A(c) of B.E Act . On arrest, all arrest formalities maintained and inform his family members regarding arrest.
