Sir,
I do hereby lodge written complaint, empowered by the Electricity Act 2003 read with Amendment Act 2007 against Haripada Jana S/O Kanailal Jana; Anupganj; P.S.- Panskura, Dist- Purba Medinipur, for commission of theft in respect of electricity u/s 135 (1) (b) of Electricity Act 2003 and Amendment Act 2007 which stated here under. Today i.e. 04.05.2017 at around 01:15 pm. I - Sri Surya Prakash Singh, AE & SM, Panskura CCC along with 1) Dibyendu Sekhar Bhunia, DE(S&LP), Purba Medinipur Region, 2) Mr. J.S. Neogi, Special officer (S&LP), Purba Medinipur region, 3), Sri Sisir Majumder, SAE, Panskura CCC, 4) Fatik Seth, Hg SR LM, Panskura CCC & Other officials had been to the village Anupganj for inspection purpose. At first we arrived in the domestic premises of Haripada Jana S/O Kanailal Jana, Vill - Anupganj, P.S.- Panskura, Dist- Purba Medinipur. During inspection it was found that Haripada Jana has got one electric connection vide contract account no. - 201044129 and meter no. - TA220646 instead of that he was consuming electricity dishonestly through direct hooking from nearest LT. Line using single core, PVC wire grey colour with hooking device bypassing the energy meter in his domestic premises in view of less recording of energy unit into the energy meter thereby causing less recording of energy in the installed meter for his wrongful gain and thus WBSEDCL losses revenue. As per physical inspection the load was found to be 0.6 Kva.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the unauthorized hooking wire from LT mains and then some portion of single core, PVC wire 2 nos grey colour with hooking device 5meters approximate each along with a yellow card in the name of Mr. haripada Jana vide I.no - 4096312 was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials were duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 01:35 pm.

Thus the aforesaid accid. person -namely Haripada Jana S/O Kanailal Jana, Anupganj; P.S.- Panskura, Dist- Purba Medinipur has committed theft of electricity unauthorisely for domestic purpose and thereby he is liable to be prosecuted u/s 135 (1)(b) of Electricity Act 2003 read with Amendment Act 2007. Hence you are requested to take cognizance against the accid. person treating this complain as FIR.
