Sir,

I ASI Dilip Chakraborty of Panskura PS lodged a written complaint as suo-moto after producing the accused 1) Paran Kumar (19) S/O- Dataram Mahato of Babupur PS Rajmahal Dist-Sahebgangy State-Jharkhand 2) Raja Kumar Mahato (20) S/O Budhan Mahato of Babupur PS Rajmahal Dist-Sahebgangy State- Jharkhand including the following seizure articles to the effect that in course of night petrol duty on 12/13.05.17 along with C/911 Sanku Mondal, C/424 Sukdeb Mondal and NVF Manik Das all of Panskura PS vide C.C. No- 1881 Date-12.05.17 at 02:05 hrs an information was received over phone by a person who refused to disclose his identity that 6/7 persons has assembled near Keshapat on SH (Ghatal-Panskura Road) with a view to commit dacoity at petrol pump or in any adjacent place.)

On receipt of the information I appraise the fact to OC Panskura PS and duty officer of Panskura and as order I along with force had been to nearby Keshapat and called some local witnesses with request for accompanying us, but they refused to go with us. Then myself and forces had been to Keshapat and found that 6/7 persons are assembled besides SH (Panskura -- Ghatal Road) in the dark and gossiping with each other as we approached them they tried to run away but we chased and after hot chase we managed to apprehend the above mentioned two accused persons while rest of the accused persons managed to escape in the dark. )

On interrogation the above noted persons disclosed their name and addresses as noted above and we searched them and on search 1) one Iron made Bhojali from the possession of Raja Kumar Mahato and 2) one Iron rod about 2ft length from the possession of Paran Kumar have been seized all the above mentioned two articles under proper seizure list in between 03.05 hrs to 03.25 hrs on 13.05.17 under seizure list from their possession duly signed by the both persons and witnesses

On interrogation the above noted persons failed to give any satisfied reason for their presence at that place at that time and also possession of above articles in their possession. Accordingly after observing all procedure I arrested above noted 02 accused persons as they committing offence or for making preparation to committing Dacoity and assembled for committing Dacoity nearby.

After observing all procedure and formalities and also producing above noted arrested 02 accused persons and seized articles I, beg to submit prayer for starting a case under proper section of law against 1) Paran Kumar (19) S/O- Dataram Mahato of Babupur PS Rajmahal Dist-Sahebgangy State- Jharkhand 2) Raja Kumar Mahato (20) S/O Budhan Mahato of Babupur PS Rajmahal Dist-Sahebgangy State- Jharkhand and other unknown 4/5 accused persons for regular investigation as well as for taking law full action against them.
