I, A.S.I. Bijoy Kr. Pal of Panskura PS beg to submit that, on the night 12/13.05.17 myself along with C/- 455, Barendranath Mahata, C/-861, Gouram Cakraborty, C/- 886, Nema Patra and N.V. F Amit Mondal were in night patrol duty vide Panskura PS C.C. No. 1879 dtd. 12.05.17 and at about 20:45 hrs while we started NAKA checking duty at near Mechogram on NH-06 at that time one Kolkata bound unknown motor cycle dashed C/-886, Nema Patra. Resulting in which C/- 886, Nema Patra sustained grievous injury in his persons. This incident was took place due to rash and negligent driving on the part of the rider of said unknown motor cycle. Injured Constable Nema Patra was admitted at Baroma Sirona Hospital at Mechogram under Panskura PS.
