I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Gobinda Nayek S/O Lt Gopal Nayek ; Golghat ; P.S.- Panskura, Dist- Purba Medinipur, for commission of theft in respect of electricity u/s 135 (1) (b) of Electricity Act 2003 and Amendment Act 2007 which stated here under Today i.e. 17.01.2017 at around 01:05 pm. I Dibyendu Sekhar Bhunia DE(S&LP) , Purba Medinipur Region , Tamruk along with 1) Surya Prakash Singh , AE & SM , Panskura CCC 2) Musfakur Rahman , LM , Panskura CCC & Other officials had been in the village Golghat for inspection purpose. At first we arrived in the domestic premises of Gobinda Nayek S/O Lt Gopal Nayek, Vill - Golghat , PO- Golghat, P.S.- Panskura, Dist- Purba Medinipur . During inspection it was found that Gobinda Nayek has got one electric connection vide contract account no. - 222277157 and meter no. - B505935 instead of that he was consuming electricity dishonestly through direct hooking from nearest L.T. Line using single core, PVC wire black colour 2 no.s with hooking device bypassing the energy meter in his domestic premises in view of less recording of energy unit into the energy meter thereby causing less recording of energy in the installed meter for his wrongful gain and thus WBSEDCL losses revenue. As per physical inspection the load was found to be 0.75 KW.

As theft of electricity was detected during the inspection at first we disconnected the service connection , removed the unauthorized hooking wire from L.T.mains and then some portion of single core, PVC wire black colour 2 no.s with hooking device 3meters approximate each was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list . The above seized materials were duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 01:25 pm.

Thus the aforesaid accd. Person namely Gobinda Nayek S/O Lt Gopal Nayek ; Golghat ; P.S.- Panskura, Dist- Purba Medinipur committed theft of electricity unauthorizedly for domestic purpose and thereby he is liable to be prosecuted u/s 135 (1)(b) of Electricity Act 2003 read with Amendment Act 2007.

Hence you are requested to take cognizance against the accd. person treating this complain as FIR.
