Dear Sir,

This is for your kind information and necessary action that on 17.05.2017 at around 10:50 am around 30-35 persons led by Mr. Najir Hossain S/O Abdul Mojid, Mr Jakir Hossain S/O Abdul Majid, Sk Jahangir S/O Lt Jalal and Sk Soiful S/O Monu Ali from village Paschim Nekra under Panskura PS came in the office of the undersigned and created hooliganism. They obstructed the office staff in performing their official duties, used obscene language and abused them. They even threatened them and then damaged official properties in the cash section of the office of the undersigned forcing the cash section to stop thus hampering collection. They left after this hooliganism at around 11:05 am. One of the miscreants Sk Soiful S/O Monu Ali accidentally cut his hand while damaging the property and was rushed to nearby hospital by the mob.

Video footage of the incident, clearly showing the faces of these anti social persons from village Paschim Nekra, is copied into a CD and enclosed with this complaint. The footage clearly shows them threatening office staff, hampering office work and breaking/damaging government property

I, Surya Prakash Singh, AE & SM, Panskura CCC, do hereby lodge a complaint against Mr. Najir Hossain S/O Abdul Mojid, Mr Jakir Hossain S/O Abdul Majid, Sk Jahangir S/O Lt Jalal and Sk Soiful S/O Monu Ali and the unknown 30-35 persons from village Paschim Nekra as shown in the video CD (Enclosed) as per Indian Penal Code Section 429, 353, 506.
