Sir,

I have the honour to beg to submit that on 01.08.15 on receipt of the written complaint of Dr Sharmila Majumder MO, Uttar Mechogram BPHC to the effect that a patient namely A Thanga Raj @ Thangan A (50) S/O- Ammasai @ Arumugam of 518 Church Street, Edayarpalayam PS-B/14 Kumiamuthur Dist- Coimbatore, Tamilnadu PIN-641008 was brought to Uttar Mechogram BPHC with a history of RTA in dead condition on 01.08.15 at 04:40 hrs by a person of Tamilnadu.

Over this and U/D case vide Panskura PS U/D case No-47/15 Dated-01.08.15 was started was recorded by SI MM Roy OC, Panskura PS who was pleased to endorsed this case to me for taking steps. Accordingly I took up its investigation.

During investigation I along with C/861 Goutam Chakraborty of Panskura PS had been to Uttar Mechogram BPHC at Pitpur and after observing all procedure I prepared Surathal report over the dead body of said A Thanga Raj. Nothing the details of injury and physical appearance and other details and forwarded the same to district Hospital, Purba Medinipur at Tamluk for preparing holding PM report. Over it so, as to ascertain the actual cause of death of deceased. I send reminder to Hospital authority Tamluk to collect the PM report but it was to delay latter on I collected the PM report of deceased A Thanga Raj vide PM No-602 of 01.08.15 in c/w Panskura PS U/D case No-47/15 Dated-01.08.15 in which the Autopsy Surgeon Dr M Patra, MO of District Hospital Purba Medinipur at Tamluk opined that, "The cause of death in my opinion due to the antimortem the nature."

Due local inquiry was made it came to light that on 01.08.15 at about 03:45 hrs while the said A Thanga Raj was taking tea in a road side tea stall on NH 6 at Kallswar under Panskura PS. One unknown vehicle knock down due to rush and negligent driving on the part of the driver of the said vehicle as a result said A Thanga Raj sustain grievous injury on his person and he was brought to Uttar Mechogram BPHC where the on duty MO declared him death.

So, I pray a cog case under prayer proper section of Low may kindly be started against the driver of unknown vehicle in this respect for investigation relevant documents are attached here.
