Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Dilip Kar (30) yrs appx s/o Haripada Kar of Naranda Ward No-05 PS Panskura Dist Purba Medinipur along with the below noted seized items, I beg to state that on the special mobile on 19.01.17 Myself PSI Qamar Haseed and C/1194 Birendranath Maity and C-641 Abhijit das were in special patrolling duty I received a secret source information that one person named as Dilip Kar was running a business of selling of I/D liquors to different persons from his hotel cum I/D liquors shop situated at Naranda ward -04 under Panskura PS, Accordingly to pursue the information myself PSI Qamar Haseed along with force left for village Naranda. I reached at Naranda at 19.55 hrs and as pointed by my source we cordoned the shop of Dilip Kar, seeing the police force the persons purchasing the I/D liquors managed to run away but we managed to apprehend the above named Dilip Kar, who was selling I/D liquors. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched his shop and below noted quantity of I/D liquor were found from his possession at his shop. On enquiry it was known he was running the businesses of selling of I/D liquor since last few days. On demand he failed to produce any license for possession of the I/D liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 20.05 to 20.20 hrs on 19.01.17. Description of the seized items:-1) I/D liquor contained in One Plastic jarican of 5 litres containing approximately 05 lts I/D Liquors in it. I also took 375 ml of I/D liquor in a bottle as sample, from the above mentioned seized item. I arrest him at 20.25 hrs on 19.01.17 and brought him to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against him U/S 46 A(c) of B.E Act . On arrest, all arrest formalities maintained and inform his family members regarding arrest.
