Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Chandi Charan Samanta (65 years) S/O-Lt. Sital Samanta of Vill-Paramanandapur PS-Panskura Dist-Purba Medinipur along with the below noted seized items under proper seizure list and relevant memos and I beg to state that today on 15.06.2017 at 06.45 hrs myself received a secret source information that one person named as Chandi Charan Samanta was running a business of selling of I/D liquors to different persons from his house cum shop at Paramanandapur. To pursue the information myself SI Raban Hembram along with C/424 Sukdeb Mondal, C/911 Sanku Mondal and C/1194 Birendra Nath Maity left for village Paramanandapur. I reached at Paramanandapur at 07.05 hrs and as pointed by my source we cordoned the said house cum shop, seeing the police party the I/D liquors seller tried to flee way but we managed to apprehend him, who was selling liquors from his house cum shop at Paramanandapur. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched his house and below noted quantity of I/D liquors was found from his possession at his house cum shop. On enquiry it was known said Chandicharan Samanta was running the businesses of selling of I/D liquors liquor since last few months. On demand he failed to produce any license for possession of selling liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 07.15 hrs to 07.25 hrs on 15/06/2017.

Description of the seized items:-1) I/D liquor contained in one 10 (Ten) ltrs plastic jerrican , approx 04 ltrs of I/D liquor and also took 375 ml of I/D liquors in a bottle as sample.

I arrest him at 07.25 hrs on 15.06.17 and brought him to PS and I submit this complaint to start case against him U/S 46 A(c) of B.E Act .On arrest, all arrest formalities maintained and inform his family members regarding arrest.
