Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Asit Pakhira (58) s/o -Lt Biren Pakhira of Mudhusudhanbarh, Word No. 07, PS Panskura Dist Purba Medinipur along with the below noted seized items, I beg to state that on my Spl. mobile duty at PS area on 01/07/17 at about 19.05 hrs, received a secret source information that one person named as Asit Pakhira was running a business of selling of I/D liquors to different persons from his House cum Shop situated at Mudhusudhanbarh. To pursue the information myself ASI Dilip Chakraborty along with C/ 424 Sukdeb Mondal and C/1696 Ekadosi Dhal left for Mudhusudhanbarh. I reached at Mudhusudhanbarh at 19.25 hrs and as pointed by my source we cordoned the House cum Shop of Asit Pakhira, seeing the police force the persons purchasing the I/D liquors managed to run away but we managed to apprehend the above named Asit Pakhira, who was selling I/D liquors. We approached local people to witness the search but none came forward to witness the search and seizure. So, in the presence of only police team I searched his House cum Shop and below noted quantity of I/D liquor were found from his possession at his House cum Shop. On enquiry it was known he was running the businesses of selling of I/D liquor since last few months. On demand he failed to produce any license for possession of the I/D liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 19.45 hrs to 20.05 hrs on 01/07/17. Description of the seized items: 1) I/D liquor contained in one 10 lts. Plastic jarican containing approximately 05 lts. I also took 375 ml of ID liquor in a bottle as sample, from the above mentioned seized item. I arrest him at 20.05 hrs on 01/07/17 and brought him to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against him U/S 46 A(c) of B.E Act. On arrest, all arrest formalities maintained and inform his family members regarding arrest.
