Sub: - Complaint for possession of I/D liquor without any license.

In producing herewith one accused person namely Rabindranath Tili (58) S/O- Lt Matilal Tili of Radhaballavchak PS Panskura Dist Purba Medinipur along with the below noted seized items, I beg to state that on 03.07.17 at about 20:15 hrs, received a secret source information that one person named as Rabindranath Tili was running a business of selling of I/D liquors to different persons at Radhaballavchak. I diarized the information vide Panskura PS GDE No.142 dated 03.07.17 and to pursue the information myself ASI Syed Milad Ahamed along with C/ 141 Nakul Koley and C/1598 Kanai Lal Karak left for village Radhaballavchak. I reached at Radhaballavchak at 22.45 hrs and as pointed by my source we cordoned the Radhaballavchak Bazar, seeing the police force the persons purchasing the I/D liquors managed to run away but we managed to apprehend the above named Rabindranath Tili, who was selling I/D liquors. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched said persons and below noted quantity of I/D liquor were found from his possession in a bag. On enquiry it was known he was running the businesses of selling of I/D liquor since last few days. On demand he failed to produce any license for possession of the I/D liquors. So I seized the below noted quantity of I/D liquors from his possession in presence of police witnesses in between 22.55 hrs to 23.25 hrs on 03.07.17. Description of the seized items:-1) I/D liquor contained in one 05 lts. Plastic jarican containing approximately 04 lts. in a bag 2) 7 (Seven) pieces of plastic glass. I also took 375 ml of ID liquor in a bottle as sample, from the above mentioned seized item. I arrest him at 23.25hrs on 03.07.16 and brought him to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against him U/S 46 A(c) of B.E Act. On arrest, all arrest formalities maintained and inform his family members regarding arrest.
