Sir,

I do hereby lodged written complaint, empowered by the electricity act 2003 read with amendment act 2007 against One Asit Kumar Raut S/O Lt Haripada Raut, VILL- Hatisal, P.S.- Panskura, Dist- Purba Medinipur, for commission of theft in respect of electricity u/s 135 (1)(b) electricity act 2003 and ammendment act 2007 which stated here under.

Today i.e. 04.07.2017 at around 12:05 pm. I Shri Surya Prakash Singh, AE & SM, Panskura CCC, Panskura along with 1) Mr. Sisir Majumder, SAE, Panskura CCC 2) Sk Musfakur Rahaman, LM, Panskura CCC & Other officials had been to the village Hatisal for inspection purpose. At first we arrived in the domestic premises of Asit Kumar Raut S/O Lt Haripada Raut, VILL- Hatisal, P.S.- Panskura, Dist- Purba Medinipur. During inspection it was found that Asit Kumar Raut has got one electric connection vide contract account no. - 222034621 and meter no. - 5S004735 instead of that he was consuming electricity dishonestly by tampering the incoming service cable before entry to the energy meter causing less recording of energy unit into the energy meter by bypassing of meter for his wrongful gain causing loss of revenue of WBSEDCL at the tune of load 2 KVA.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the tampered PVC service cable from L.T.mains and then some portion of service cable 2 core black colour with tampered portion of PVC cable yellow and red colour 1 mtr approx was seized under memo of a seizure list in presence of witnesses and Asis Kumar Raut, brother of Asit kumar Raut & their signature duly obtained on seizure list. The above seized materials was duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses and Asis Kumar Raut, brother of Asit kumar Raut. The inspection team left the premises on 12:25 pm.

Thus the accd. Person Asit Kumar Raut S/O Lt Haripada Raut, VILL- Hatisal, P.S.- Panskura, Dist- Purba Medinipur, has committed theft in respect of electricity unauthorizedly for domestic purpose.

Hence you are requested to take cognizance on the illegal act of the accd. Person Asit Kumar Raut S/O Lt Haripada Raut, VILL- Hatisal, P.S.- Panskura, Dist- Purba Medinipur under the per view of electricity act 2003 read with amendment act 2007 u/s 135 (1) (b) of the said act and treated the same as FIR.
