Sub: - Complaint for possession of I/D liquor without any license.

In producing here with the accused person namely Pratima Das (38) w/o Mukta Das PS Panskura Dist Purba Medinipur along with the below noted seized items with sample label, I beg to state that on the Night mobile on 22.01.17 Myself PSI Qamar Haseed and C/352 Kartick Manna and C-466 Tajammal Haque were in Night patrolling duty at morning time I received a telephonic source information that one lady named as Pratima Das was running a business I/D liquors having no licence illegally on the road side at Pannapukur under Panskura PS, Accordingly to pursue the information myself PSI Qamar Haseed along with force left for village Pannapukur. I reached at Panna Pukur at 06.50 hrs and as pointed by my source we cordoned the place where Pratima Das was standing with I/D Liquors, We could succeed to intercept the above named Pratima Das with 2 bladder having on her possession abt 25 litres each on her possession, who was running a business of I/D liquors. We approached local people to witness the search but none came forward to witnesses the search and seizure. So, in the presence of only police team I searched her bag and below noted quantity of I/D liquor were found from her possession from road side. On enquiry it was known he was running the businesses of I/D liquor since last few days. On demand he failed to produce any valid documents/ license for possession or running business of the I/D liquors. Accordingly, I seized the below noted quantity of I/D liquors from hes possession with sample having label in presence of police witnesses in between 06.55 to 07.15 hrs on 23.01.17 morning. Description of the seized items:-1) I/D liquor contained in 2 bladder having 25 ltrs I/D Liquors in each in it. (Total 50 ltrs I/D liquors in it.) I also took 375 ml of I/D liquor in a bottle as sample, from the above mentioned seized item. I arrest her at 07.15 hrs on 23.01.17 morning and brought her to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against her U/S 46 A(c) of B.E Act. On arrest, all arrest formalities maintained and inform hes family members regarding arrest.
