Sub: - Complaint for possession & selling of I/D liquor without any license.

In producing herewith two accused persons namely i) Rajesh Hansda (22) s/o S/O-Lt Haura Hausda of Jaykrishnapur PS Panskura Dist Purba Medinipur and ii) Nandini Hansda(38) w/o Padda Hansda of same village along with the below noted seized items, I beg to state that during my special raid duty at PS area on 28.01.17 at about 16.25 hrs, received a secret source information that the above noted persons were running a business of selling of I/D liquors to different persons from the house cum shop situated at Joykrishnapur PS Panskura Dist. Purba Medinipur. To pursue the information myself PSI Qamar Haseed along with C/293 Sankar Neogi, C/-1378 Manash Desmukh and L/C 1775 Tulika Jana(Mondal) left for village Joykrishnapur. I reached at Joykrishnapur village at 16.45 hrs and as pointed out by my source we cordoned the house cum shop and on seeing the police force the I/D liquor sellers tried to run away but we managed to apprehend and detain the above named Rajesh Hansda and Nandini Hansda they disclosed their identity as noted above. We approached local people to witness the search but none came forward to witness the search and seizure. So, only in the presence of police team I searched shop house cum shop of said Rajesh Hansda and Nandini Hansda and as shown and produced by him below noted quantity of I/D liquor were found from their possession. On demand they failed to produce any license in respect of possession or selling of I/D liquors. So, I seized the below noted quantity of I/D liquors from their possession in presence of police witnesses in between 16.45 hrs to 17.05 hrs and arrested them after observing all formalities.

Description of the seized items: -1) 05 (five) ltrs. (approx) I.D. liquors containing in a 05 ltrs. plastic container. I also took 375 ml of ID liquor in a bottle as sample, from the possession of Rajesh Hansda (22) s/o S/O-Lt Haura Hausda of Jaykrishnapur PS Panskura Dist Purba Medinipur and 2) 04 (four) ltrs. (approx) I.D. liquors containing in a 05 ltrs. plastic container. I also took 375 ml of ID liquor in a bottle as sample, from the possession of Nandini Hansda(38) w/o Padda Hansda of Jaykrishnapur PS Panskura Dist Purba Medinipur. The above mentioned seized items with 02 accused along with force left for PS.

I pray that a specific case u/s- 46A© of B.E. Act. 1909 may kindly be registered against i) Rajesh Hansda (22) s/o S/O-Lt Haura Hausda of Jaykrishnapur PS Panskura Dist Purba Medinipur and ii) Nandini Hansda(38) w/o Padda Hansda of do and oblige.
