Sub: - Complaint for possession of I/D liquor without any license.

In producing here with the accused person namely Sanatan Hansda (36) s/o Chunaram Hansda of Borda PS Panskura Dist Purba Medinipur along with the below noted seized items with sample label, I beg to state that on the special evening mobile on 06.02.17 Myself ASI Bijoy Kr Pal and accompanying C/1562 Anup Kumar Singha and C-455 Borendranath Mahato were in evening patrolling duty at evening time I received a telephonic source information that one person named as Sanatan Hansda was running a business I/D liquors having no licence illegally on the road side at Borda Canal Bazar beside his grocery shop under Panskura PS. Accordingly to pursue the information myself ASI Bijoy Kr Pal along with force left for village Borda. I reached at Borda at 17.15 hrs and as pointed by my source we cordoned the place where Sanatan Hansda was standing with I/D Liquors. We could succeed to intercept the above named Sanatan Hansda with a 5 litres container having appx 4 litres I/D liquors in it. The people who were purchasing I/d liquors managed to run away, Sanatan Hansda running a business of I/D liquors. We approached local people to witness the search but none came forward to witness the search and seizure. So, in the presence of only police team I searched his container and below noted quantity of I/D liquor were found from his possession from road side at Borda beside his grocery shop. On enquiry it was known he was running the businesses of I/D liquor since last few days. On demand he failed to produce any valid documents/ license for possession or running business of the I/D liquors. Accordingly, I seized the below noted quantity of I/D liquors from his possession with sample having label in presence of police witnesses in between 17.15 to 17.35 hrs on 06.02.17. Description of the seized items:- 1) I/D liquor contained in a plastic 5 litres container having appx 4 ltrs I.D liquors in it.) I also took 375 ml of I/D liquor in a bottle as sample, from the above mentioned seized item. I arrest him at 17.35 hrs on 06.02.17 and brought him to PS for possession of I/D liquors and on return to PS I submit this complaint to start case against his U/S 46 A(c) of B.E Act. On arrest, all arrest formalities maintained and inform his family members regarding arrest.
