Sir,

I do hereby lodge written complaint, empowered by the Electricity Act 2003 read with Amendment Act 2007 against Subhash Pakhira S/O Banshidhar Pakhira; Jassora ; P.S.- Panskura, Dist- Purba Medinipur, for commission of theft in respect of electricity u/s 135 (1) (b) of Electricity Act 2003 and Amendment Act 2007 which stated here under.

Today i.e. 07.02.2017 at around 02:50 pm, I Shri Surya Prakash Singh AE & SM, Panskura CCC along with 1) Shri Sisir Majumder, SAE, Panskura CCC, Panskura CCC 2) Mr Fatik Seth, Hg Sr I.M, Panskura CCC 3) Shri Musfakur Rahman, L.M - Panskura CCC & Other officials has been to the village Jassora for inspection purpose. At first we arrived in the domestic premises of Subhash Pakhira s/o- Banshidhar Pakhira, VII, Jassora, P.S.- Panskura, Dist- Purba Medinipur. During inspection it was found that Subhash Pakhira has got one electric connection vide contract account no. - 201784853 and meter no. - TA541830 instead of that he was consuming electricity dishonestly through direct hooking from nearest L.T. Line using single core, PVC wire black colour 2 no.s with hooking device bypassing the energy meter in his domestic premises in view of less recording of energy unit into the energy meter and thus WBSEDCL losses revenue. As per physical inspection the load was found to be 1 KVA.

As theft of electricity was detected during the inspection at first we disconnected the service connection, removed the unauthorized hooking wire from L.T.mains and then some portion of single core, PVC wire 2 no.s black colour with hooking device 10meters approximate and one yellow card in the name of accused, Subhas Pakhira vide s.no. 459469 each was seized under memo of a seizure list in presence of witnesses & their signature duly obtained on seizure list. The above seized materials were duly packed & labeled at the inspection site & signature of the witnesses also obtained on the packet & label. I also prepared an inspection report duly signed by the witnesses. The inspection team left the premises on 03:10 pm.

Thus the aforesaid accid. Person namely Subhash Pakhira S/O Banshidhar Pakhira; Jassora ; P.S.- Panskura, Dist- Purba Medinipur has committed theft of electricity unauthorisely for domestic purpose and thereby he is liable to be prosecuted u/s 135 (1)(b) of Electricity Act 2003 read with Amendment Act 2007. Hence you are requested to take cognizance against the accid. person treating this complain as FIR.
