I was informed about the incident by telephone in the morning of 22.01.2017 at 7:10 a.m. and when I reached the school, I found the two almirahe, lockers and drawers of my table were kept open. The files were being ransacked thoroughly and they were lying here and there in the room. An amplifier unit, two catchers, remote and the bell of the school were stolen on that night.

I would like to add further that some offenders often enter the school campus after sunset and drink alcohol in the campus and write slang languages on the wall and door of the bathroom of the school. It can be delayed to inform you for finding the files & other things of the school.

Under this circumstance I request you to take necessary steps to remedy this.
