Dear Sir,

I do hereby lodged a written complaint, against one Sri Biswajit Pattanayak S/O- Rabindranath Pattanayak of Vill.&P.O-Lakhakuri, P.S -Panskura, Dist- Purba Medinipur for commission of theft in respect of electricity as stated hereunder.

On 27.02.2017 at 1.15 p.m, I, Sri Soumen Mondal D.E & S.M, Pratappur C.C.C along with Sri Aniruddha Pradhan SE(E), S&LP-HQ, Sri Dibyendu Sekhar Bhunia, D.E(E), S&LP,PMRO, Sri Bappaditya Samanta, A.E,S&LP-HQ, Sri Niladri Chakraborty, Sr. S.A.E(E), Pratappur CCC, Sri Uttam Kr. Samanta, H.G.Sr. L.M from Pratappur CCC and other officials had been to the village Lakhakuri for inspection purpose. During inspection it was found that Sri Biswajit Pattanayak was consuming electricity dishonestly for agriculture purpose by way of direct hooking from nearby LT mains causing loss of revenue of WBSEDCL. Further it is revealed that one deemed STW connection was in the same premises i.f.o Sri Panchanan Pattanayak (Con. ID 222031813), grandfather of Biswajit Pattanayak having outstanding dues of Rs 101856.00 & that service connection was previously used by the accused person & disconnected on 13.12.2013 due to nonpayment of aforesaid dues. So the nexus is established.

As theft of electricity was detected during inspection, the unauthorized hooking wires from LT main were removed and thereafter some portion of hooking wire PVC single core (3nos.) cable blue & white in colour (approx. length of 2 mtr. each) with hooking device were seized in presence of the witnesses under a memo of seizure list and their signature duly obtained on it.

The above materials were duly packed and labeled at the inspection site and signature of the witnesses obtained on the Packed & label. I also prepared an inspection report at site & duly signed by the witnesses on it. After inspection our inspection team left the premises on 1.35p.m.

Thus the accused person i.e Sri Biswajit Pattanayak S/O- Rabindranath Pattanayak of Vill &P.O.Lakhakuri, P.S -Panskura, Dist- Purba Medinipur has committed an offence u/s 135(1)(a) of the Electricity Act 2003 read with amendment Act 2007 in view of theft of electricity.

So you are requested to take cognizance of this complaint and treat it as FIR.
