Dear Sir,

I do hereby lodged a written complaint, against one Sri Jaydip Chakraborty S/O- Ardhendu Chakraborty Vill-Amdan, P.S -Panskura, Dist- Purba Medinipur, user of the agriculture premises of Rani Hansda bearing Con. ID 201457265 & Monorama Chakraborty bearing Con. ID 201457268 for commission of theft in respect of electricity as empowered by, electricity u/s 138(1)(b) of the Electricity Act 2003 read with amendment Act 2007 as stated hereunder.

On 27.02.2017 at 2.20 p.m, I, Sri Soumen Mondal D.E & S.M, Pratappur C.C.C along with Sri Aniruddha Pradhan SE(E), S&LP-HQ, Sri Dibyendu Sekhar Bhunia, D.E(E), S&LP,PMRO, Sri Bappaditya Samanta, A.E, S&LP-HQ, Sri Kohinoor Ali, Sr. SAE(E), Pratappur CCC, Sri Niladri Chakraborty, Sr. S.A.E(E), Pratappur CCC, Sri Utam Kr. Samanta, H.G.Sr. L.M from Pratappur CCC had been to the village Amdan for inspection purpose.

At first we visited the agriculture premises of Smt. Rani Hansda. During inspection it was found that the user Sri Jaydip Chakraborty was dishonestly enjoying electricity for agriculture purpose by illegally reconnecting the aforesaid service connection (Con. ID 201457265) which was disconnected on 10.06.2016 due to non-payment of outstanding amount of Rs. 2596/-.

In Second phase on the same day (27.02.2016) at 2.40 p.m, I, Sri Soumen Mondal D.E & S.M, Pratappur C.C.C along with above mentioned team had been to the agriculture premises of Smt. Monorama Chakraborty. During inspection it was found that the same person, Sri Jaydip Chakraborty dishonestly enjoying electricity for agriculture purpose by illegally reconnecting the aforesaid service connection (Con. ID 201457268) which was disconnected on 20.06.2016 due to non-payment of outstanding amount of Rs. 58816.00.

So Sri Jaydip Chakraborty was using electricity for wrongful gain causing loss of revenue of WBSEDL. Sri Jaydip Chakraborty has committed theft in respect of power to the tune of load 4.38kva which ascertained from the physical inspection for both the cases.

Due to the physical obstruction from the accuse Sri Jaydip Chakraborty & other cultivator the inspection team is unable to disconnect the unauthorisedly reconnected connection & couldn't seize anything from the premises.

Thus the accused person Sri Jaydip Chakraborty S/O- Ardhendu Chakraborty Vill-Amdan, P.S -Panskura, Dist- Purba Medinipur, has committed an offence u/s 138(1)(b) of the Electricity Act 2003 read with amendment Act 2007 in view of theft of electricity from our LT mains.

You are requested to take cognizance of this complaint and treat it as FIR.
