Dear Sir,

I do hereby lodged a written complaint, against Sri Radhakanta Pattanayak (User) and Consumer-Purnendu Pattanayak both S/O- Lt.Gobordhan Pattanayak of Vill & P.O-Lakhakuri, P.S -Panskura, Dist- Purba Medinipur for commission of theft in respect of electricity as stated hereunder.

On 27.02.2017 at 1.45 p.m, I, Sri Dibyendu Sekhar Bhunia, D.E (S&LP) Regional Office, Purba Midnapore along with (1) Sri Aniruddha Pradhan S.E(S&LP), HQ, Bidyut Bhavan 2) Sri Bappaditta Samanta, AE(S&LP) HQ, Bidyut Bhavan 3) Sri Jiban Sankar Neogi, S.O(S&LP) Regional Office, Purba Midnapore. 4) Sri Soumen Mondal D.E & S.M 5) Sk.Kohinur Ali Sr.S.A.E(E) 6) Sri Chittaranjan Bag, L.M, all are attached to Pratappur CCC and other officials had been to the village Lakhakuri for raid & inspection purpose. During inspection it was found that Sri Radhakanta Pattanayak (User) and Consumer-Purnendu Pattanayak both S/O- Lt.Gobordhan Pattanayak of Vill & P.O-Lakhakuri, P.S -Panskura, Dist- Purba Medinipur has got one energy meter bearing con. ID-222035520 & meter no-ST318637 for his Industrial premises to run his Husking Mill. Instead of that he was consuming electricity dishonestly by way of direct hooking from nearby LT mains for less recording of energy through energy meter for his wrongful gain causing loss of revenue of WBSEDCL, Sri Radhakanta Pattanayak (User) and Consumer-Purnendu Pattanayak has committed theft in respect of electricity to the tune of load 12.5KVA which ascertained from the physical inspection.

As theft of electricity was detected during inspection, the service connection was not disconnected due to physical obstruction by the consumer and user. But we removed only unauthorized hooking wire from LT main and thereafter some portion of hooking wire Single core (3 nos wire) pvc wire blue & white in colour (approx. length of 3 mtr. each) with hooking device was seized in presence of the local witnesses, Sri Shyam Sundar Pattanayak S/O- Lt Gobardhan Pattanayak and other members of inspection team under a memo of seizure list and their signature duly obtained on it.

The above materials were duly packed and labeled at the inspection site and signature of the witnesses obtained on the Packed & label. I also prepared an inspection report at site & duly signed by the witnesses on it. After inspection our inspection team left the premises on 2.20p.m.

Thus the accused person i.e Sri Radhakanta Pattanayak (User) and Consumer-Purnendu Pattanayak both S/O- Lt.Gobordhan Pattanayak of Vill & P.O-Lakhakuri, P.S -Panskura, Dist- Purba Medinipur has committed an offence u/s 135(1)(a)(b) of the Electricity Act 2003 read with amendment Act 2007 in view of theft of electricity & also obstructed public servant to discharge his official duty.

So you are requested to take cognizance of this complaint and treat it as FIR.
