I do hereby lodge complaint empowered by the Electricity Act, 2003 to the effect that Sri Biswanath Mandal, S/O- L.T. Pulin Behari Mandal, Village- Rupchak, P.O. Mahadole, PS- Panskura, Dist- Purba Medinipur has committed theft of electricity U/S 135 of the E. Act, 2003 read with Amendment Act, 2007 as stated here under.

On 03.03.2017 at about 11:00 am, I Sri Uttiya Roy Chowdhury, A.E. & SM, Gourangapur Customer Care Centre along with (i) Sk. Anub Ali, I.M, Gourangapur C.C.C., (ii) Sri Tapun Kr. Prannisk, I.M, Gourangapur C.C.C., went to the Domestic(Rural) premises of Biswanath Mandal, S/O- L.T. Pulin Behari Mandal, Village- Rupchak, P.O. Mahadole, PS- Panskura, Dist- Purba Medinipur and found that he was consuming electricity dishonestly by way of direct hooking from the nearest I.T.O.II. main of WBSEDL. As theft of electricity was detected during the inspection some portion of PVC Alum. wire with hooking device was seized in presence of the witnesses and their signature obtain on the seizure list. The seized article are duly packed, sealed & labeled at the inspection site and signatures of the witnesses obtain on the sealing label.

The inspection team left the aforesaid premises on 03.03.2017 at about 11:20 am. Thus the Biswanath Mandal, S/O- L.T. Pulin Behari Mandal, Village- Rupchak, P.O. Mahadole, PS- Panskura, Dist- Purba Medinipur has committed an offence U/S 135(1) (a) of E. Act, 2003 read with Amendment Act, 2007.
