On attaching herewith one arrested male accused person namely Rabindranath Shee (68) s/o Lt Gopinath of vill Jabda, P.S-Patashpur, Dist. Purba Medinipur, in custody under proper receipt of arrest with seized articles all relevant papers, I beg to submit report that today on 14.01.17 at 05:45 hrs during Night mobile duty I SI Abhijit Patra of Patashpur PS received an information by reliable source that one Rabindranath Shee (68) s/o Lt Gopinath of vill Jabda, P.S-Patashpur, Dist. Purba Medinipur, stored Country spirit at his Tea stall at Jabda Bazar under Patashpur PS and selling at that area to local people in lieu of money without any licence. After receiving the said information I informed to O/C Patashpur PS and as per order of O/C Patashpur PS, myself along with force rushed to the spot at 06.30 hrs at Jabda Bazar to conduct a raid and work out over such information, and found one person selling Country spirit from his tea shop to local people. Then I managed to apprehend a person as mentioned by my source. On being asked the apprehended person disclosed his identity as Rabindranath Shee (68) s/o Lt Gopinath of Jabda, P.S-Patashpur, Dist. Purba Medinipur. Then I conducted search at his tea shop after observing all formalities in presence of the witnesses. On search I found 03 (three) bottles of SUN Country Spirit (Containing 600 ml each) i.e. 550 ml bottles, Total Rs 165/-) in his shop. During enquiry I came to know from the accused person and also on interrogation said Rabindranath Shee disclosed to me that he selling Country Spirit to local people illegally. He was asked whether he had any valid papers in support in respect of such businesses and possession of such Country spirit but he unable to produce any valid document on demand or to have any paper for the such of Country Spirit, hence his offence is punishable U/S 46 A(c) of the Bengal Excise Act.

Accordingly the Country Spirit were seized from the possession of the accused person Rabindranath Shee s/o Lt Gopinath of vill Jabda, P.S-Patashpur, Dist. Purba Medinipur under receipt duly signed by witnesses and the accused person and I arrested him as being punishable u/s 46 A (c) of Bengal Excise Act 1909. During arrest the accused person was informed about the ground of his arrest and memo of arrest was prepared and submitted all sorts of assistance as per law.

Under such circumstances I do hereby lodged complaint against accused person Rabindranath Shee (68) s/o Lt Gopinath of vill Jabda, P.S-Patashpur, Dist. Purba Medinipur under U/S 46 A (c) of the Bengal Excise Act, 1909 to initiate a case for investigation.
