Dear Sir,

I do hereby lodge this written complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that one Sri Nirmal Kumar Patra, S/O: Lt. Netai Patra of Village : Natunpukur, P.O.: Makrampur, P.S.: Patashpur, Dist.: Purba Medinipur has committed theft of electricity under section 135 of the electricity act 2003 read with amendment act 2007 as stated hereunder,

On 11.05.2017 at about 12.30 PM I, Sri Aniruddha Hazra, AE (E) & SM, Patashpur CCC, WBSEDCL along with Sri Manas Maity, AE (U), S&LP Wing Contai Division, WBSEDCL & Sri Pradip Kumar Chakraborty, Special Officer, S&LP Wing Contai Division, WBSEDCL & Sri Sunil Kumar Bauri, Linesman, Patashpur CCC and others went to inspect the commercial service connection at Natunpukur mouza as a part of routine supervisory checking and found that one Sri Nirmal Kumar Patra, S/O: Lt. Netai Patra of the said village was engaged in unauthorized use of electricity at his commercial hotel premises by means of bypassing the energy meter by tampering the incoming service cable before entry to the energy meter installed against his electrical service connection with consumer id 201788383 for bypassing the energy consumption into the energy meter for less recording of energy to run various electrical appliances with estimated tune of load 1.32 KVA for commercial purpose for his wrongful gain causing loss of energy and revenue of WBSEDCL.

As theft of electricity was detected, at first the said tampered electrical service cable was disconnected from the live electrical network of WBSEDCL and then some portion of the said 2 core 6 sq. mm black colored PVC coated service cable along with bypassing arrangements including 2 no single core stranded 1.5 sq. mm. black colored PVC coated bypass wire was dismantled & seized in presence of the witness and signature of the witness obtained on the seizure list. The seized article were duly packed and labeled at the inspection site and the signature of the witness obtained on the label. Sri Gouranga Patra, S/O: Sri Nirmal Kumar Patra @ Nirmal Patra was present during inspection and acknowledged the same by putting his signature on the inspection report, seizure list & label. Thereafter the inspection team left the aforesaid premises at about 01.00 PM.

The accused Sri Nirmal Kumar Patra @ Nirmal Patra, S/O: Lt. Netai Patra of Village : Natunpukur, P.O.: Makrampur, P.S.: Patashpur, Dist.: Purba Medinipur has committed theft of electricity under section 135 (i) (b) of electricity act 2003 with amendment act 2007.

You are hereby requested to take cognizance of this offence and treating this complaint as FIR.
